#### Information You Provide

- 3. Degree Studies at West Suffolk College will communicate with you by email, letter, phone or text, depending on the contact information you provide on your application. You must regularly check your correspondence and inform Degree Studies at West Suffolk College if there are any changes to this information. It is your responsibility to comply with deadlines/communication associated with your application.
- 4. Unless your results are transmitted to Degree Studies at West Suffolk College via UCAS or a partner HEI of the college or confirmed by your school or college when you apply, you will be required to produce satisfactory evidence of your qualifications. You must provide us with an original transcript or certificate; or by agreement with the Degree Studies Office a clear and legible copy that has been authenticated by the issuing organisation or other authorised person.
- 5. If you are transferring credits to Degree Studies at West Suffolk College from prior study, we will require evidence of a satisfactory original or certified copy of any transcripts prior to your enrolment. Consideration for admission will be given in accordance with the Recognition of Prior Learning Policy.
- 6. As part of your application, you will be required to declare any relevant criminal convictions as defined by the Criminal Convictions Policy. If a criminal conviction is not declared and subsequently becomes known, this will be treated in accordance with Degree Studies at West Suffolk College Criminal Convictions Policy and could result in withdrawal of an offer or from the course.
